BETWEEN

PURPOSE OF MOU

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

Co - Operation

1.1. Both parties are united by common interests and objectives, and they shall establish channels of communication and cooperation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information relevant to secure additional opportunities for one another.

1.2. The cooperation between First Party and Second party will facilitate effective utilization of the intellectual capabilities of the Second party providing significant inputs to them in developing suitable Teaching/ Training systems, keeping in mind the needs of the First Party.

CLAUSE 2

SCOPE OF THE MOU

- 2.6. The Second Party will actively engage to help the delivery of the training and placement of students of the Second Party into internships/jobs.


VALIDITY


1. The validity of the agreement is one year from the date of agreement.
