

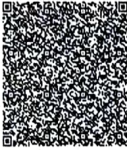

MEMORANDUM OF UNDERSTANDING

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

**Clause 1
CO-OPERATION**

Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the First Party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the Second Party.

**Clause 2
SCOPE OF THE MOU**

The First Party will extend the necessary support to deliver guest lecturers to the students of the Second Party on the technology trends and in-house requirements.


The First Party will actively engage to help the delivery of the training and placement of students of the Second Party into internships / jobs.


